- Positive behaviour will be encouraged through clear and consistent guidelines and discipline techniques that clearly reinforce the centre's expectations.
- The management committee and educators will display a positive approach to their roles within the service that promotes recognition of the centre as high quality and an essential resource for the local community.
- BBASVCC programmes, policies, procedures and record keeping etc. will adhere to all standards and codes of practice appropriate to our of school hours care.
