Policy Statement

The approved provider and nominated supervisor at Brisbania Before & After School & Vacation Care Centre, will facilitate effective care and health management of children with asthma, and the prevention and management of acute episodes of illness and emergencies.

This policy should be read in conjunction with the Medical Conditions and Medication Administration policy.

Background Information:

• Asthma is a condition in which the bronchi (air tubes of the lungs) go into spasm and become narrower. Excess mucous is produced, causing the person to have difficulty breathing. Asthma is particularly common in children.

• Signs and symptoms may be unable to get air, progressively more anxious, short of breath, subdued or panicky, focussed only on breathing, coughing, wheezing, blue around lips, earlobes and fingertips, or unconsciousness.

Procedures:

1. Services will:

• Ensure families provide information on the child's health - medications, allergies, asthma plan completed by a doctor.

•Parents are to complete the centre's risk minimisation plan yearly

•Ensure parents/carers are given a copy of the centres, dealing with medical conditions policy.

• Ensure Regulations and other guidelines are adhered to – administration of medication and first aid.

• In any case where a child is having an acute asthmatic attack, staff will administer first aid according to the child's Asthma Plan, a Doctor's instructions or a trained certified supervisor who has completed Emergency Management of Asthma in the workplace.

• Under the Education and Care Services National Regulation 94, in the case of an asthma emergency, medication will be given to the child even without an authorisation and parents/caregivers and emergency services will be notified as soon as possible.

2. Staff will be aware of aspects of the outdoor environment listed on child's minimisation plan that may be triggers for asthma including but not limited to dust mite, plants, mildew, chemicals, glue, paint, and animals.

3. Staff will reduce exposure of children and staff to indoor allergens by: regularly cleaning furniture, toys, and equipment, preventing growth of mould, not using chemicals around children and controlling pests.
